- 2. In the case of levels per amine component > 20 mg/kg. The analysis result suggests that the article submitted has been manufactured or treated by using azo colourants banned under the Ordinance on Commodities.
- In case of a result between 15 and 25 mg/kg. We remark that due to the error range of the method, these measurement values represent a border line case.
